**Sub: Addition to Clause – 17 of the General Condition of Contract – Cartage Contracts.**

In continuation to Circular No. 551 dated 31/7/2002, an addition to Clause – 17, 17A & 17B is made as Clause 17C for Cartage Contracts.

**CLAUSE 17 C:**

Provided further that in respect of carriage contracts the Security Deposit of the contractor shall not be refunded before the expiry of 3 months period after issue of the certificate of completion of work or till the final bill has been prepared and passed which ever is later.

It is enjoined upon all concerned to add the above clause for contracts of carriage of materials for future contracts.


**Sub: Wide Publicity of Tender Notices.**

Central Vigilance Commission vide its Circular dt: 22.11.2006 stressed upon improving vigilance administration by leveraging technology: Increasing transparency through effective use of websites in discharge of regulatory, enforcement and other functions of Govt. Organisations. In this regard, a meeting was held under the Chairmanship of Engineer Member, DDA on 7.2.2007 wherein Officers from Engineering Wing, Vigilance Department, Systems Wing and Add Agencies were present.

After due deliberations and discussions, it was decided that:

- i) All tender notices irrespective of cost must be posted on DDA's Website well in advance as per prescribed period.
- ii) All award letters belonging to works, work orders, supply orders purchase orders irrespective of cost be uploaded on DDA's Website within a week's time.
- iii) The information about posting of Tender Notices on Website be projected in the scrutiny note of tenders.
