- 2. The technical bids shall be opened online at Siri Fort Sports Complex on date 20/03/2019 In the prescribed date & time in the presence of a committee or their representatives by authorized bid openers. Financial bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given.
