Online tenders are invited **through e-tendering mode** on behalf of Delhi Development Authority, (Sports Wing) for the following works at **Poorv Delhi Khel Parisar**. **The tender shall be uploaded in two parts, namely, 'Part -I' containing Technical Bid and 'Part – II' comprising 'Financial Bid'. The bid not uploaded in accordance with the prescribed manner will not be accounted for at all.** Only those agencies/ Firm/ Person **having successfully completed three similar nature of works** each costing not less than 40% of the estimated cost put to tender, or **two similar completed works** each costing not less than 60% of the estimated cost put to tender, or **one similar completed work** costing not less than 80% of estimated cost put to tender during the last five years ending previous day of last date of submission of tender in Government Department, Public Sector Undertaking, Govt. Schools with annual turnover more than 30% of the estimated cost in each year during the immediate last three consecutive financial year ending March **2018** duly certified by Chartered Accountant are entitled to apply. A proof thereof should be uploaded with the Technical Bid. The tenderer should be registered with the Department of Trade & Taxes, GST, GNCTD and furnish a copy of registration with the tender.

- As per instructions issued by CRB, DDA, no hard copy of any document will be required to be submitted by the tenderes till the opening of the tenders. Hard copies of relevant documents will be required from the lowest tenderers only.
- In part-I of the tender, i.e., Technical Bid, the tenderer shall upload details of experience, i.e., certificates of satisfactory completion, duly attested, of similar nature of works undertaken by them; authenticated proof showing annual turnover. In case of company / firm, an attested copy of Registration Certificate and Article of Association/ **Partnership Deed** is also furnished. Part-II of the tender should contain Financial Bid indicating monthly charges (per month) offered by the tenderer.
- Tender documents can be obtained/downloaded on the e-tendering portal i.e. www.eprocure.gov.in /eprocure/app or www.dda.org.in upto last date of submission of tender. Earnest money amounting to

Rs. 60,732/- shall be deposited through RTGS/NEFT in the account of “CAU SPORTS DDA” having account No. 0167104000254427 with “IDBI Bank”, Friends Colony, Delhi, (IFSC. IBKL0000167). The unique transaction reference of RTGS / NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The DDOs concern will get earnest money verified from their banks based on the unique transaction reference no. against each RTGS / NEFT payment before the tenders are opened.

4. Similar Nature means “having completed works of running swimming pools of at least 25 meters length through **licensing/ providing manpower**” in Government Department, Public Sector undertaking, Govt. Schools including KVS.
5. The bidder will use one UTR for one work only. In case, it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.”
6. The intending tenderer should ensure before tendering in DDA that the requisite fee has been already deposited with CRB.

Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.

1. The unique transaction reference on NEFT/RTGS against EMD shall be placed online at specified location for Tender for above work. First cover containing “Technical Bid” as well as “reference of EMD”.
2. The technical Bids shall be opened online at 11.00 AM on **20.03.2019** in the presence of a committee or their representatives by authorized bid openers. Financial Bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Financial Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
3. The Tenderer should furnish **Rs. 60,732/-** as Earnest Money in the form of RTGS. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However, no interest payable on the earnest money.
4. The tender shall be submitted online in two parts, viz., technical bid and price bid.

Technical Bid

The Tenderers are required to furnish following documents in technical bid:-
