Please refer to your application dated 17-8/11 regarding booking of vacant land for temporary use to hold religious/social marriage. You are hereby granted permission to hold religious/social marriage for an account of use DDA's vacant A-3/6 Vikas Puri measuring 2000 sq. mts. on 27/11/11 to 29/11/11 for temporary use on the following terms & conditions as already accepted by you -

- The said booking for temporary use permitted above shall not be misused for any other purpose. If any misuse is found at site, the land shall be vacated with force without any notice by the DDA and DDA shall not be responsible for any damage or loss on the site. In such eventuality, your security deposit shall stand forfeited.
- The said land shall also be vacated at your risk and cost if more land is to be attached then permitted by more than the permitted days as above. Under such circumstances, DDA shall not be responsible for any damages or losses to your irrevalible properties. Your security deposit shall also be forfeited under such circumstances.
- The proxy booking is not allowed. In case it is found by the filed staff of DDA that temporary booking has been obtained by you misrepresenting the facts, and/or practicing any fraud and/or through impersonation, the permission so granted shall automatically stand cancelled and you will be liable for eviction forcibly, besides criminal proceeding, on forfeiture of your security deposit, DDA shall not be liable for any damage and/or losses sustainable to you during such forcible eviction.
- It must that in DDA's properties such as boundary wall, grill fencing, gates, roads & trees etc. is damaged due to your damage in this regard your security shall stand forfeited by the value of the value damage.

- 5 You will have to ensure the fire safety norms prescribed by the Chief Fire Officer (CFO) IIT, IITD shall have no responsibility of any fire accident or other loss due to your stupidity, carelessness or sheer negligence. (Copy enclosed)
- 6 No parking vehicles inside the IITD's vacant land is allowed
- 7 You will have to make your own arrangement for water, electricity etc.
- 8 Use of loud sound speakers, PA's, physical music systems and flood etc. is subject to various Acts/Laws in force and you will have to get permission where it is required from the authority concerned
- 9 In case the banking is cancelled due to any reason by you and the annation of box can be obtained is made before one month from the date of function you shall be entitled for 90% and 10% refund of annation is within the 15 days from the date of function. Such refund shall be allowed only on properly shown requests and these orders shall be applicable with prospective effect.
- 10 Banker as permitted above is non-transferable. In case of unauthorized transfer of banking is detected by field staff of IITD, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions besides cancellation and forfeiture of security deposit
- 11 IITD reserves the right to cancel the said permission without any notice in case of violation of the said terms and conditions
- 12 IITD also reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.
