In pursuance of representations/ request for regularization of unauthorized occupation in Geeta Colony, it has been decided to provide a last opportunity to such persons who could not avail the facility of regularization under the scheme earlier.

Applications are invited from all such persons who have unauthorizedly occupied Govt. land in Geeta Colony prior to June, 1977 and could not avail the opportunity for regularization earlier, such unauthorized occupants/ persons are directed to submit following documents with their application:-

1. Original proof of occupation as proof of stay in said premises prior to June, 1977.
2. Proof of up-to-date payment of damages in respect of property under regularization with effect from the date of occupation.
3. Copy of old ration card (prior to June, 1977).
4. Present Ration Card & Election I. Card/ Aadhar Card (in proof of occupation of the plot).
5. Proof of House Tax/ Electricity Bill/ Water Bills etc. paid in respect of property under regularization.
6. Extract of Voter's list of 1977.
7. Location plan of the site, if available.
8. Any other proof of residence of pre-June, 1977.
9. Three specimen signature and photo of the person(s), who is in occupation of the premises.
10. An affidavit on a non-judicial stamp paper worth Rs.10/- duly attested declaring therein:-
 - i) That you/ your wife/ husband/ or any of your dependant relation, including unmarried children do not own any other house/ plot/ flat in Delhi/ New Delhi, Cantonment as required under the Scheme of LARGE SCALE REQUISITION/ Development and disposal of land in Delhi.
 - ii) That there is no Court case, No misuse, No litigation, No complaint, No unauthorized construction/ encroachment on Govt./Public land, No sub-division, No amalgamation, no any dispute and no family dispute pending in any court of Law.

You are requested to upload this letter on DDA's website so that the same can be visible to general public.
