b) Experience certificate: -

e) Solvency Certificate or Net Worth Certificate: -

Solvency of the amount equal to 40% of the Estimated Cost put to the Tender (ECPT) Or Net Worth Certificate of Minimum 10% of the Estimated Cost put to Tender issued by certified Chartered Accountants (On the format prescribed in Form B-1).

f) Financial Information: -

The bidder should furnish the Annual Financial Statement for the Last Five Years in (Form- 'A'). Solvency Certificate in (Form- 'B') or Net Worth Certificate in (Form- 'B-1').

The bidder should not have incurred any Loss (Profit after tax should be Positive) in more than Two Years during available Last Five consecutive Balance Sheets.

The bidder should have had Average Annual Financial Statement for the Last Five Years in (Form- 'A') (Gross) on Construction Works equal to 50% of the Estimated Cost of work put to tender.

- 2. The intending bidder must read the terms and conditions of CPWD-6 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- 3. Information and instructions for bidders will form part of NIT & to be uploaded on website.
- 4. Information and instructions for bidders posted on website shall form of bid document.
- 5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from www.dda.org.inor central public procurement portal https:// eprocure.gov.in/eprocure/app free of cost.

- 8. The intending bidder must have valid class-II digital signature to submit the bid.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 10. Contractor can upload documents in the form of JPG format and PDF format.
- 11. Certificate of financial turn over: At the time of submission of bid contractor may upload affidavit / certificate from CA mentioning financial turnover of last 3 years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
- 12. Contractor must ensure to quote percentage rate. If a tenderer does not quote any percentage above / below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
- 13. The eligibility and / or technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them at a later date.
