- The intending bidder must read the terms and conditions of CPWD-6 carefully, He should tender. only submit his bid if he consider himself eligible and he is in possession of all the
- Information and instructions for bidders will form part of NIT & to be uploaded on website.
- Information and instructions for bidders posted on website shall form of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from www.dda.org.inor central public procurement portal https://eprocure.gov.in/eprocure/app free of cost. Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class - II digital

- Contractor must ensure to quote percentage rate. If a tenderer does not quote any percentage above / below on the total amount of the tender or any section / sub head in 12. percentage rate tender, the tender shall be treated as invalid and will not be considered as
- The eligibility and / or technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying 13. the technical bid shall be communicated to them at a later date.
