- 1 Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.
- a) Should have satisfactorily completed the works as mentioned below during the Last Seven Years ending Last Date of the Month Previous to the one in which Tenders are invited.
- 1.1 The work is estimated to cost Rs. 10,84,812/- this estimate, however, is given merely as rough guide.

Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below. Joints ventures are not accepted. Criteria of eligibility for submission of bid documents.

- a) Completion certificates should be issued by the officer not below the rank of Executive Engineer or equivalent will have to be furnished along with the application.
- b) The completion certificate must clearly indicate: -
 - Date of completion of works.
 - ii. Nature of work with estimated cost.
 - iii. That the work has been completed satisfactorily.
 - iv. Cost of work done.

1.2 Criteria of eligibility for submission of bid documents

a) Experience certificate: -

The bidder should have satisfactorily completed the similar works in Central Govt. / State Govt. / PSUs during the Last 7 (Seven) Years ending Last Date of the Month Previous to the one in which Tenders are invited.

Three Similar Works each of value not less than Rs. 433925.00 (40% of Rs. 10,84,812/-)

Two Similar Works each of value not less than Rs. 650887.00 (60% of 10,84,812/-)

One Similar Work of value not less than Rs. 867850.00 (80% of 10,84,812/-)

b) Definition of Similar Works:- "SITC/RMO of CCTV & allied equipments" The value of executed works shall be brought to current costing level by enhancing the actual value of work at Simple Rate of 7% Per Annum calculated from the date of completion to last date of receipt of submission for bid.

c) Solvency Certificate or Net Worth Certificate: -

Solvency of the amount equal to 40% of the Estimated Cost put to the Tender (ECPT).

OR

Net Worth Certificate of Minimum 10% of the Estimated Cost put to Tender issued by certified Chartered Accountants (On the format prescribed in Form B-1).

d) Financial Information: -

The bidder should furnish the Annual Financial Statement for the Last Five Years in (Form- 'A'), Solvency Certificate in (Form- 'B') or Net Worth Certificate in (Form- 'B-1').

The bidder should not have incurred any Loss (Profit after tax should be Positive) in more than Two Years during available Last Five consecutive Balance Sheets.

- The intending bidder must read the terms and conditions of CPWD-6 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- Information and instructions for bidders will form part of NIT & to be uploaded on website.
- Information and instructions for bidders posted on website shall form of bid document.

Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class – II digital signature to submit the bid.

 But the bid can only be submitted after depositing E-tendering processing fee, and uploading the mandatory scanned documents.

- 12. Contractor must ensure to quote percentage rate. If a tenderer does not quote any percentage above / below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
- 13. The eligibility and / or technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them at a later date.
