Online tenders are invited through e-tendering mode on behalf of Delhi Development Authority, (Sports Wing) for the following works at Dwarka Sports Complex/DDA. The tender shall be uploaded in two parts, namely, 'Part -I' containing Technical Bid and 'Part – II' comprising 'Financial Bid'. The bid not uploaded in accordance with the prescribed manner will not be accounted for at all. **Only those agencies/ Firm/ Person having satisfactorily completed three similar nature of works each costing not less than 40% of the estimated cost put to tender, or completed two similar nature of works each costing not less than 60% of the estimated cost put to tender, or completed one similar nature of work costing not less than 80% of estimated cost put to tender during the last seven years ending previous day of last date of submission of tender in Government Department or Public Sector undertaking with annual turnover more than 30% of the estimated cost in each year during the immediate last three consecutive financial year ending March 2019 duly certified and audited by Chartered Accountant having valid UDIN are entitled to apply. Without this tenders would not be considered. A proof thereof should be uploaded with the Technical Bid. The tenderer should be registered with the GST Department and furnish a copy of registration with the tender.**

(Note : Definition similar nature of work : The agency having the experience of each type of category mentioned in the schedule of quantity/BOQ).

The tenders will be opened Sr. AO (Sports)/CAU at SFSC Conference Hall.

द्वारका स्पोर्ट्स कॉम्प्लेक्स/डीडीए में निम्नलिखित कार्यों के लिए दिल्ली विकास प्राधिकरण (स्पोर्ट्स विंग) की ओर से ई-टेंडरिंग मोड के माध्यम से ऑनलाइन निविदाएं आमंत्रित की जाती हैं। निविदा को दो भागों में अपलोड किया जाएगा, अर्थात् भाग-1 जिसमें तकनीकी बोली और भाग-II शामिल हैं, जिसमें वित्तीय बोली शामिल है। निर्धारित तरीके से अपलोड नहीं की गई बोली का हिसाब बिल्कुल नहीं होगा। केवल उन एजेंसियों/फर्म/व्यक्ति ने संतोषजनक ढंग से तीन समान कार्यों को पूरा किया है, जिसकी लागत निविदा में रखी गई अनुमानित लागत का ४०% से कम नहीं है, या निविदा के लिए रखी गई अनुमानित लागत का ६०% से कम नहीं है, प्रत्येक कार्य की दो समान प्रकृति को पूरा किया है, या पूरा काम की एक समान प्रकृति के लिए पिछले सात वर्षों के दौरान निविदा के लिए रखा अनुमानित लागत का ८०% से कम नहीं है सरकारी विभाग या सार्वजनिक क्षेत्र के उपक्रम में निविदा प्रस्तुत करने की अंतिम तारीख के पिछले दिन के दौरान वार्षिक कारोबार के साथ प्रत्येक वर्ष में अनुमानित लागत का 30% से अधिक मार्च २०१९ को समाप्त तत्काल पिछले तीन वित्तीय वर्ष के दौरान विधिवत प्रमाणित और लेखा परीक्षा चार्टर्ड एकाउंटेंट वैध UDIN होने के लिए आवेदन करने के हकदार हैं। इसके बिना निविदाओं पर विचार नहीं किया जाएगा। इसका एक प्रमाण तकनीकी बोली के साथ अपलोड किया जाना चाहिए। टेंडरकर्ता को जीएसटी विभाग में पंजीकृत होकर टेंडर के साथ रजिस्ट्रेशन की प्रति प्रस्तुत करनी चाहिए।

Technical Bid:

The Tenderers are required to furnish the following documents in technical bid:-

- vi. Scanned copy of ESI, EPF Registration.
- vii. Scanned copy of PSARA.
- viii. Scanned copy of Proof of requisite fee deposited with Contractors Registration Board.
- ix. Scanned copy of Turnover Certificate duly audited and certified by Chartered Accountant having valid UDIN.
- x. Scanned copy of satisfactory completion certificates for each type of category as per schedule of quantity/BOQ.
- xi. Scanned copy of undertaking on a non-judicial stamp paper of Rs. 100/- that agency is not blacklisted or debarred by any Govt. /PSU or private organization Agency/Firm/Person/Tenderer.
- xii. Scanned copy of undertaking on a non-judicial stamp paper of Rs. 100/- regarding ESI, EPF as per clause of NIT.
- xiii. Any other documents required as per clauses of NIT.

Any tender found lacking with respect to the necessary information and /or documents and/or Earnest Money with the Technical bid will not be considered.

Note(1):- The bidder will use one UTR for one work only. In case, it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.”

Note (3):- No Hard copy of any document will be required to be submitted by the tenderers till the opening of the tenders. Hard Copies of relevant documents will be required from the lowest tenderer only.
