**Instructions for Candidates: -**

1. The candidates are advised to report for walk-in-interview on the scheduled date latest by 10:00 AM at Conference Hall, 5th floor, Delhi Development Authority, Vikas Minar, New Delhi-110002, failing which they will not be allowed to appear for interview under any circumstances.
2. The posts are temporary and engagement is purely on contractual basis initially for a period of 01 year (extendable upto 03 years depending upon the performance of individual candidate and requirement of DDA) and will confer no right to the candidates for permanent employment against the said posts.
3. Candidates are requested to bring duly filled Application form (in prescribed format) along with 05 photocopies of the duly filled application form in addition to 02 passport size photographs and all original documents along with one set of self-attested photocopies of the documents in support of the educational qualification and experience, if any, on the date of interview.
4. The criteria for selection shall include the marks obtained by the candidate in the required essential qualifications for the post, relevant experience along with the marks obtained in interview.

DDA reserves the right to impose a minimum cut-off percentage of marks in the essential qualifications obtained by the prospective candidates in case of large number of applicants turn out for the interview. The decision in this regard will be taken on the spot and no representation of any kind shall be entertained in this regard.
