Chief Engineer (East Zone) presented the above item in the 138<sup>th</sup> EAC meeting held under the chairmanship of VC, DDA on 27.08.2019 at 05.30 PM for approval, the minutes of the above meeting was circulated vide EM.1(37)87/Vol. 128/2463 dated: 30.08.2019.

The Estimate Approval Committee DDA is pleased to accord the A/A & E/S for the above said work for an amount of Rs. 25,46,56,653/- (Rupees Twenty Five Crores Forty Six Lakhs Fifty Six Thousand Six Hundred Fifty Three Only) which includes Rs.22,89,04,857/- (Rupees Twenty Two Crores Eighty Nine Lakhs Four Thousand Eight Hundred Fifty Seven Only) as works outlay including 3% contingency and Rs.2,57,51,796/- (Rupees Two Crores Fifty Seven Lacs Fifty One Thousand Seven Hundred Ninety Six Only) as Departmental Charges @ 11.25%.

The expenditure shall be charged under the head of a/c of Nazul A/C-II to the Major Code (Head) of 2422 and Minor Code (Head) of 12. It may be ensured that provision has been kept for the same in RBE 2019-20 and BE-2020-21.

Finance Member, DDA has accorded the Financial Concurrence to the preliminary estimate for the above mentioned work and the same has been conveyed by Accounts Officer (Works)-III, DDA vide No. F2(2)/AO(W)-III/2019-20/PE/54 dated 18.07.2019 for an amount of Rs.25,46,56,653/- (Rupees Twenty Five Crores Forty Six Lakhs Fifty Six Thousand Six Hundred Fifty Three Only) which includes Rs.22,89,04,857/- (Rupees Twenty Two Crores Eighty Nine Lakhs Four Thousand Eight Hundred Fifty Seven Only) as works outlay including 3% contingency and Rs. 2,57,51,796/- (Rupees Two Crores Fifty Seven Lacs Fifty One Thousand Seven Hundred Ninety Six Only) as Departmental Charges @ 11.25%.

Accord of A/A & E/S is subject to compliance of the conditions from Sl. No. i) to xii) laid down in above mentioned Financial Concurrence and 138<sup>th</sup> EAC Minutes of Meeting as well as all other codal formalities and departmental instructions/circulars issued time to time.

**Sub-Head :** Asita – Old Railway Bridge to I.T.O. Barrage (Eastern Bank).

The agenda was presented by Shri S.K. Arya, Chief Engineer (EZ) explaining about the detail of various works to be taken up under this estimate.

Financial concurrence to the preliminary estimate for the work of restoration and rejuvenation of Yamuna River Floor Plains from Asita–Old Railway Bridge to ITO Barrage (Eastern Bank) has been accorded by Finance Wing, DDA vide sanction No. 05/2019-20 for an amount of Rs. 13,27,74,217/- (Rupees Thirteen Crore Twenty Seven Lacs Seventy Four Thousand Two Hundred Seventeen only) and conveyed by Accounts Officer (Works)-III, DDA vide No.F.2(1)/AO(W-III)/2019-20/PE/30 dated 04.06.2019.
