Minutes of the Meeting

A review meeting on the issues raised by Sh. Vijender Gupta, MLA was held on 13.07.2017 at 04.00 PM in E.M.'s chamber, VikasSadan, under the chairmanship of E.M./DDA. The list of the officers who attended the meeting is enclosed as **Annexure 'A'**. The following issues were reviewed and decisions were taken as under: -

(1) Development of Parks with public conveniences in sports field/ large parks of Rohini and their maintenance.

Sh. V.K. Saluja intimated that water has been provided in all toilets. Only one toilet is remaining for water connection. Work will be completed by 14.07.2017. He further stated that directed that the toilet at Sector-8, Rohini would be completed by 20.07.2017 in all respect.

(2) Construction of Community Hall in Sec-8 Rohini.

Community Hall at Sector-8, Rohini:- Sh. V.K. Saluja intimated that there is some public resistance in starting the work of community center. MLA (Rohini) was requested to resolve.

(3) Construction of Socio Cultural Center at Rohini.

It was directed that file be put up to VC/DDA for seeking his approval for placing in Screening Committee.

(4) Developing Green Belt from Rohini Court Sec-14 to DeepaliChowk Sec-3 along outer Ring Road by erecting boundary wall & wire fencing & plantation.

Sh. Ishwar Chandel, EE/RPD-2 intimated that work of C/o of boundary wall is in progress and same will be completed by 31.07.2017.

(5) Providing flats/land etc. to J.J. dwellers of Suraj park J.J. Clusters situated in H&F Block of Sector 18 Rohini as per DDA policy of Rehabilitation.

CE(RZ) intimated that file has been sent to LM Branch for survey of the area. It was also intimated that Architect wing, DDA has to propose EWS housing project in the area. It was directed that the matter should be put up in file for in principle approval of the project from VC, DDA.

Further Director (Plg.) Rohini informed that the site required for re-location of JJ cluster wherein convenient shopping centre, night shelter and multipurpose community centre

were already proposed have been suggested to be relocated to block H and Block F and the proposal for modification for the same was also prepared for placing before the Screening Committee.

(6) Development of Parking site, Sector-14, Rohini.

CE(R) intimated that tender of the work has been awarded and work will be completed by 31.08.2017.

(7) Issue Regarding Vacant land at pocket -8A, Block H, Sector-15 Rohini.

Hon'ble MLA desired to get the change of land use of site as park. Director (Plg.) Rohini informed that the plan of the site has already been approved wherein one community room, two religious sites, one convenient shopping centre and ESS (existing) have already been proposed. For Community room, and religious facilities possession /allotment has already been made. In view of this the site cannot be changed to park.

(8) Regarding Community Hall at Sector- 18 Rohini.

Hon'ble MLA desired to convert the site under reference as multipurpose community hall. Director (Plg.) Rohini informed that site measuring 1551sqmt at H Block have been identified. The proposal for modification in the lay out plan have already been prepared for placing before the screening committee for consideration. Sr. Arch. Socio cultural informed that since the area is less than 2000 sq.mt. only community hall can be constructed with provision of basement for parking in this site.

(9) Community Hall at Sector-5,6 & 11, Rohini.

Sh. A.K. Singh, SE(Elect.) intimated that community halls are almost completed. Only NOC from fire department is pending. Visit from fire department has already been conducted. It was directed to pursue the matter with fire department.

(10) Development of Sector-23/33, Sports Complex.

It was intimated by CE(Project) that estimate for the proposed sports complexes has already been approved by EM, DDA. The file is in finance branch.

(11) Development/maintenance of Sardar Patel Jheel at Pooth Kalan.

Sh. V.K. Saluja, SE/CC-9 intimated that cleaning and malba removal from the area has been done and plantation work is in progress in this area.

MLA requested that parks at Sector-13, Sector-15 & Sector-14 (Dayanand Vatika) at Rohini should be develop on priority. Same to be dealt by PC(Hort. & L/S).

The meeting ended with the vote of thanks to the chair.

The next review meeting is fixed for 03-08-2017 at 04:00 PM which will be held under the chairmanship of EM, DDA in his chamber.

This issues with the approval of EM/DDA.
