Brothers Pvt. Ltd. being the lowest bidder with quoted amount of Rs. 31,36,55,501/i.e. 25.74% below the estimated cost and 34.03% below the justified amount i.e. Rs. 47,54,63,860/-

Board noted that the A/A &E/S for D/o Land for Sector A-1 to A-4 Narela Project, Ph-I was accorded vide EAC Item No. 27/2006 & Sanction No. 33/2006 for Rs 12553.11 Lacs (Rs. Twelve thousand five hundred fifty three point eleven lacs only) as works outlay and Rs 1412.22 Lacs (Rs. One thousand four hundred twelve point twenty two lacs only) @ 11.25% as D.C. (Departmental Charges). The expenditure shall be charged to the head of amount "Nazul A/C-II". The A/A & E/S was conveyed by EO-II to EM vide No. EM.6(14)2006/Est./Pt./0127 dated 01-09-2006.

Board observed that NIT amount of Rs 42,23,74,767/- is much more than the provision in A/A & E/S for this sub head i.e. Rs 24,11,39,836/- (including Contingencies & Departmental Charges). Chief Engineer (North Zone) was directed to provide the details of expenditure incurred/savings in r/o complete A/A & E/S accorded for D/o Land for Sector A-1 to A-4 Narela Project, Ph-I.

The Concerned Executive Engineer, ND-10 (North Zone) vide letter no. F1(10) PS/EE/ND-10/DDA/2018-19/974 dated 08-08-2019 has submitted the expenditure/savings details as under: -

Board instructed that any deviation in agreement items, extra items / substitute items shall be dealt as per various Clauses of the Agreement & CE (NZ) shall ensure fulfillment of all codal formalities before award of work. Further the quality of work is to be ensured by CE(NZ). The savings available in A/A & E/S accorded for D/o land for Sector A-1 to A-4 Narela Project, Ph-I vide EAC Item No. 27/2006 & Sanction No. 33/2006, shall not be considered for any future works. If required, a fresh PE may be initiated for such other works as the case may be.
