1.0 Background:-

A meeting was held on 30/4/10 in the office of VC, DDA to discuss issues related to the development of infrastructure in the pockets earmarked for relocation of Chemical traders in IFC Narela. As per the approved Composite Plan., four sites have been proposed for providing other community facilities. One site (0.09 Ha.) has already been proposed for allotment to Social Welfare Department and other two sites measuring (300 to 400 Sq.mt.) may be proposed for OCF facilities as per the requirement /request. One of the four site (Area .24 Fm. Approx.) is under consideration.

2.0 Examination:-

- As per approved layout plan the site measuring 0.24 hact has been proposed for OCF 2.1 facilities in Block-'A' of Composite Plan for the Relocation of Chemical Traders at IFC,
- As per MPD-2021 Night Shelter site could be accommodated in other Community 2.2 facilities(OCF) for area measuring 1000 Sqm. of land for a population of I Lakh.
- 3.0 Proposal:-

One site measuring 1000 Sqm. has been carved out of OCF Pocket in Block-'A' for Night Shelter. One site each for dispensary and Aangwari are also proposed.
