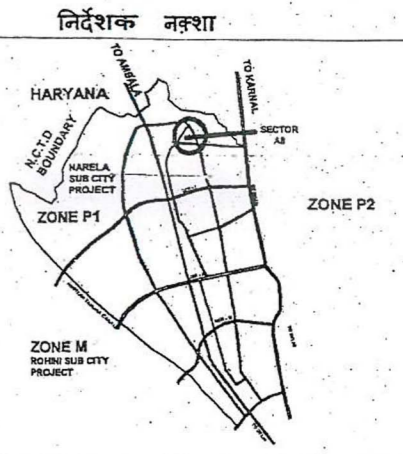

This land is part of land measuring 2.141 HA. Proposed to Central Research Institute for Ayurveda (CRIA), Ministry of AYUSH, Govt. of India.
