## F&E Circular Nol.4./2015

Sub: Revision of rates of Actual Conveyance charges/re-imbursement of local conveyance charges in respect of Non Entitled Categories.

The rates of various Travelling Allowances were fixed by the Authority vide Resolution No. 05 dated 23.05.1981. The rates of MCA, FCA & FTA in respect of entitled categories have been revised from time to time with the approval of Hon'ble LG, Delhi. The last revision in the rates of FTA/FCA/MCA was made vide F&E Circular No. 03/2012 dated 13.01.2012. However, the rates of actual conveyance charges/reimbursement of local conveyance charges in respect of non entitled categories have not been revised since 01.01.2002.

The Committee constituted for considering grant of various travelling allowances and revision of rates etc. has recommended for enhancement of existing limit for reimbursement of actual conveyance charges/reimbursement of local conveyance charges in respect of officials/officers of non entitled categories on the analogy of enhancement of travelling allowances to entitled categories of officers/officials on the same rates, as approved by the Hon'ble LG, Delhi from time to time, subject to ceiling as under:-

- (i) Employees drawing Grade pay upto Rs. 1800/- Rs. 672/- p.m.
- (ii) Employees drawing Grade Pay of Rs.1900 & above Rs. 840/- p.m.

Above ceiling will not be applicable to officials who are allowed DTC Pass. However, the DTC passes at the following rates have also been recommended by the Committee subject to revisions of rates by DTC from time to time and fulfilment of other conditions:-

- (i) Monthly pass Ordinary Bus Rs.815/- per month
- (ii) Monthly pass, AC Bus Rs.1050/- per month

These orders will take effect from May, 2015.
