

I. WAB AGENDA CE(Dwarka)

Sub: Tender for the work of

Name of Work: Construction of zonal office building including development and electrification (A turnkey project) (On Design & Build operation and maintenance basis) at Sector -10, Dwarka, New Delhi.

The case was presented by CE (Dwarka) before Board with the recommendation for acceptance of lowest bid of L1 bidder i.e. M/s C. K.

Construction at their quoted amount of Rs. 29,54,60,811.53 /- which is 12.40% below the justified amount i.e. Rs. 33,73,02,794/- and 18.34 % below the estimated cost put to tender i.e. Rs. 36,18,18,285 /- as worked out by CE (Dwarka) for above work.

The A/A &E/S for "Construction of zonal office building including development and electrification (A turnkey project) (On Design & Build operation and maintenance basis) at Sector-10, Dwarka, New Delhi" was accorded vide No. EM6(12)2020/Estt./Pt./903 dated 21.07.2020 for Rs. 38,09,23,951/- .

After due discussion & deliberation, Board agreed with the recommendation of CE(Dwarka) and accepted the lowest tender of **M/s C. K. Construction** at their quoted amount of Rs 29,54,60,811.53 i.e. 12.40% below the justified amount and 18.34 % below the estimated cost. Board instructed that CE(Dwk) shall ensure that any deviation in agreement items, extra items/substitute items shall be dealt as per relevant Clauses of the Agreement. He shall also ensure fulfilment of all codal formalities before award of work.
